


**Determination of Fabric Propensity to Surface Fuzzing and Pilling—Modified Martindale Method (#)**

Specimens from the sample were tested on a modified Martindale Abrasion Machine, using wool abradant fabric and a loading weight of 415 ± 2g. The specimens were tested for 500, 1,000, 2,000, 5,000 rubs, as stated in Annex A, Table A.1, following the Category 1 procedure for upholstery fabrics described in BS EN ISO 12945-2:2000, with additional assessments at 7,000 and 10,000 rubs, as requested by the Client. A tested specimen has been returned separately. The specimens were visually assessed at the required intervals and rated according to Table 1 of the Standard, summarised as follows:-

- 5 - no change
- 4 - slight surface fuzzing and/or partially formed pills
- 3 - moderate surface fuzzing and/or moderate pilling
- 2 - distinct surface fuzzing and/or distinct pilling
- 1 - dense surface fuzzing and/or severe pilling
